

Labour- Extension of Deadline to Request for Foreign Manpower Quota (FMQ) for the Year 2021

Ministry of Labour and Vocational Training (MLVT) – Notification No. 041/20 dated 09 December 2020 on the Extension of the Deadline to Request for FMQ for the Year 2021

In accordance with the Cambodian Labour Law and regulations, for the lodgement of an application for the annual Foreign Manpower Quota (FMQ), all factories and enterprises (which employ expatriate staff) shall submit an application for the FMQ in advance for the following year, no later than the end of November in each calendar year. For instance, an application for the 2021 FMQ shall be submitted to the Labour Office no later than 30 November 2020.

Since some factories and enterprises are still unable to apply for the FMQ for the year 2021 on time, the MLVT has extended the deadline of the application for the FMQ for the year 2021 from 30 November 2020 to 31 January 2021. Failure to apply for the FMQ for the year 2021 within the deadline shall result in factories and enterprises being subject to penalties in accordance with the Cambodian Labour Law.
